New Policy for Primary Certification Requirement for Multidisciplinary Subspecialties

Effective July 2019, those ABPN diplomates currently certified in a multidisciplinary subspecialty administered by an ABMS member board **other than** the ABPN (Brain Injury Medicine, Hospice and Palliative Medicine, Pain Medicine, or Sleep Medicine) now have the **option** of following the lead of the administering ABMS member board regarding their primary certification requirement.

- Information on <u>Psychiatry</u>, <u>Neurology</u>, <u>Child Neurology</u> and <u>Child and Adolescent Psychiatry</u> MOC Exams, offered in both February and August/September 2020, is now available on our website. Log into your <u>ABPN Physician Folios account</u> to apply.
- For physicians who wish to recertify in more than one specialty or subspecialty at the same time, information on <u>Combined MOC Exams</u> is also available.
- The subspecialties of Brain Injury Medicine, Hospice and Palliative Medicine, Pain Medicine, and Sleep Medicine are NOT available in the combined format.

IMPORTANT REMINDER: Keep up with Your MOC Requirements and Timeline Before the End of the Year

- It's not too late to catch up with your MOC activities.
- The ABPN encourages you to review the Requirement Status tab in your <u>ABPN Physician Folios account</u> for specific requirements and a C-MOC timeline. Please note that your certification status could change on January 1, 2020.
- Incomplete MOC activities could result in a change in your certification status to 'Certified-Not Meeting MOC Requirements' after a three-year

block and/or to 'Not Certified' after six years of insufficient MOC activities.
