Educational Grants Allow Diplomates Complimentary Access to both CME and Self-Assessment Credits and Specialty Specific Patient Registries for PIP Credit

Again in 2021, the <u>American Psychiatric Association (APA)</u> and the ABPN have collaborated, through an unrestricted educational grant from the ABPN, to provide diplomates with complimentary programming to satisfy ABPN Continuing Medical Education (CME), Self-Assessment CME activity requirements, including access to a patient registry for PIP credit.

The ABPN will also collaborate in 2021 with the <u>American Academy of</u> <u>Neurology (AAN)</u> through a grant from the ABPN, to provide diplomates with complimentary access to AAN programming.

Opened on Tuesday, April 20, the 80-day period to obtain input and feedback from all stakeholders who possess, use, or rely upon board certification will close on Thursday, July 8, 2021 at 11:59 p.m. CST.

Feedback received during the open Call for Comments will guide and inform the development of the final Draft Standards for Continuing Certification ("Draft Standards"), which will be considered by the ABMS Board of Directors in October 2021.
